Overall expected engagement

Approximately 11 learning days for competence development

About 4 to 6 working days for contributions and inputs to EU key actors

Eligibility and selection

All candidates must fulfill the **two eligibility criteria**:

- **Age:** between the age of 20-28 (On July 1, 2022)
- Language: good command of English

Candidates will be selected based on the following criteria:

- Their link to one or several OCTs by nationality, residence or professional/ educational/ civil society engagement
- Motivation to join the OCT Youth Network and willingness to contribute to and gain from the experience of being a member of the network
- Experience and current engagements in local community in the respective OCT(s), such as volunteering, activism or active participation.

Selection timeline

- Online applications launched via EU Survey on May 11.
- Deadline: June 3, 2022, 12:00 Brussels time
- Receipt of applications will be confirmed by email.
- Two-stage selection process :
 - ✓ First stage: all candidates will be informed of the outcome of Stage 1 (shortlist) of the application by **June 10, 2022**.
 - ✓ Second stage: shortlisted candidates will be invited for an interview between **June 15 and June 29, 2022.**
- Final results: all shortlisted candidates will be informed of the final results between July 4, 2022 and July 8, 2022.
