Executive Summary

The production of this Report on the participation of the OCTs in the EU programmes is one of the main initiatives of the Pilot project launched by DG INTPA in 2024, which aims to take stock of the situation of EU horizontal funding in the OCTs in the current Multiannual Financial Framework (MFF). The Decision on the Association of the OCTs, including Greenland (DAOG) establishes that this group of territories shall report the European Commission (EC) on the levels of their participation in the Union programmes, at mid-term and at the end of the period 2021 to 2027.

Representing the first research work covering the 2021-2027 period, the objectives of this study are to:

- Support the OCTs in their reporting to the EC on their participation in the Union programmes.
- Start the monitoring and establish a baseline of the EU projects in the OCTs for the current period, which will be continued at the end of the MFF.
- Represent a source of information for the OCTs, European Commission and other institutions, on the EU projects being implemented in the OCTs.

This document presents a comprehensive analysis of all EU projects involving an organisation based in an OCT, which were awarded funding between 1 January 2021 and 31 December 2024.

The increase in the use of EU programmes by OCTs is striking, with 344 projects identified—compared to 106 projects in the 2018 report (excluding UK OCTs). Even by the end of the previous Multiannual Financial Framework, the second report on the use of EU programmes (dated 2020) had recorded 262 projects over six years. The upward trend is even more evident when looking at the total funding received by OCTs, which reached €51,7 million during the 2021–2024 period (10 times more than the amount received 7 years earlier, on a comparable timeline). Such an increase is likely the result of a combination of factors, which can be explored in future work.

1. Introduction

1.1. OCTs and EU programmes

1.1.1. The Overseas Countries and Territories

The Overseas Countries and Territories of the European Union (OCTs) refer to Aruba (NL), Bonaire (NL), Curaçao (NL), French Polynesia (FR), Greenland (DK), New Caledonia (FR), Saba (NL), Saint Barthelemy (FR), Sint Eustatius (NL), Sint Maarten (NL), Saint-Pierre-et-Miquelon (FR), Wallis and Futuna Islands (FR) and the French Southern and Antarctic Territories - TAAF (FR), islands that are constitutionally linked to three EU Member States (the Kingdom of Denmark, France and the Kingdom of the Netherlands), and which are associated to the European Union (EU).

Surrounded by a total Exclusive Economic Zone of more than 10 million square kilometres, the OCTs are located across the globe, in the Caribbean, Pacific, Western Atlantic, and Artic regions. In relation to these Member States, the OCTs enjoy varying degrees of autonomy, depending on their internal agreements. Despite the different relations between the EU Member States and the linked territories, they are all equals in their association with the EU. OCTs play a vital role as strategic outposts of the Union in their geographical areas.

1.1.2. The status of OCTs

At present, the relationship between the EU and the OCTs is defined in the "Decision on the Overseas Association, including Greenland" (DOAG), adopted on 5 October 2021. The EU-OCTs partnership is supported by a dedicated envelope of 500 EUR million for the period 2021-2027.

The association of the Overseas Countries and Territories to the EU dates back to the origins of the European Economic Community (EEC), as the Treaty of Rome (1957) established a free-trade area between the members of the EEC and the associated countries. Currently, the Treaty on the Functioning of the EU, article 198 states that "the purpose of the association is to promote the economic and social development of the countries and territories, and to establish close economic relations between them and the Union as a whole"². The unique status of the OCTs is best exemplified by the fact that while the approximately 950.000 OCT residents are EU citizens although the territories are not part of the EU's territory nor the EU single market.

1.1.3. EU programmes in the OCTs

Full access of the OCTs to the EU programmes was granted via article 94 of the Overseas Association Decision in 2014³. In the current DOAG (EU Council Decision 2021/1764), the eligibility for Union programmes is confirmed via article 85, which indicates:

Natural persons from an OCT and, where applicable, the relevant public and private bodies and institutions in an OCT, shall be eligible to participate in and for funding from Union programmes, such as InvestEU, subject to the rules and objectives of the programmes and possible arrangements applicable to the Member State to which the OCT is linked.

EU horizontal programmes are one of the main tools for implementing EU policies, particularly in policy areas where the EU shares competencies with the Member States (e.g. environment, research) or has supporting competencies (e.g. culture, education). The goal is to ensure that EU policies achieve their objectives by promoting cooperation between the Member States (and between the Member States, OCTs and other associated countries when applicable). These programmes are characterised by common features such as being competitive, project-based and results oriented.

Access to EU programmes by the OCTs contributes to support the cooperation efforts between the OCTs and other partners, as well as ensuring that citizens of the OCTs can participate in Union initiatives on the same conditions as other Member States nationals.

1.1.4. Evolution of the access of OCTs to EU programmes

The previous edition of this report, "Report on the Participation of the OCTs in EU Programmes during the period 2014 – July 2020", highlighted an initial increase in the number of EU-funded projects involving OCTs. By the mid-term evaluation in 2018 (covering 2014–2017), 106 projects had been identified across the 13 Dutch, Danish, and French OCTs. Just 30 months later, this number had more than doubled, reaching 228 projects by July 2020—excluding 34 projects implemented in UK OCTs, which are no longer part of the EU.

The issue of the access to EU programmes was discussed during the 2024 OCTs-EU Forum, where both the OCTs and their association reaffirmed their interest in supporting this trend and enhancing their participation and development of EU projects.

To address these challenges, the Directorate-General of International Partnerships (DG INTPA), Unit B.3 in charge of relations with OCTs, in collaboration with the Association of OCTs (OCTA), launched in 2024 a pilot project to develop and fund more targeted information-sharing, capacity-building, and specialised training activities. As part of the pilot project, three main activities have been undertaken:

- Design and provision of dedicated training sessions on technical competences for the development
 of EU projects for the OCTs. Between March and June 2025, 5 online hands-on training sessions have
 been delivered two on them in English for the Dutch territories and Greenland, and three of them
 in French for the French territories reaching over 80 local actors from the OCTs.
- Production of a Guide on EU programmes for the OCTs, an overview of all the horizontal funding to which they are eligible, which includes contact information for all the programmes.
- Elaboration of the Report on the participation of the OCTs in the Union programmes at mid-term of the 2021-2027 programming period, which represents the present report.

The research carried out for this Report represents a mid-term evaluation, covering projects selected between 2021 and 2024. During this period, 344 projects were implemented in the OCTs, representing access to 12 main EU programmes and 3 dedicated EU programmes — an unprecedented level of participation on EU programmes.





1.2. Presentation of the Report

1.2.1. Objectives

The production of this Report aims to take stock of the situation of EU horizontal funding in the OCTs in the current MFF. The DOAG establishes that OCTs shall report the European Commission (EC) on the levels of their participation in the Union programmes, at mid-term and at the end of the period 2021 to 2027.

Representing the first research work covering the 2021-2027 period, the objectives of this study are to:

- Support the OCTs in their reporting to the EC on their participation in the Union programmes.
- Start the monitoring and establish a baseline of the EU projects in the OCTs for the current period, which will be continued at the end of the MFF.
- Represent a source of information for the OCTs, European Commission and other institutions, on the EU projects being implemented in the OCTs.

1.2.2. Scope of the report

This document constitutes an in-depth analysis of all the EU projects that have involved an organisation based in an OCT, that have been awarded funding over the period 1 January 2021 to 31 December 2024.

The report focused on the following main EU programmes:

- 1. Erasmus+
- 2. Horizon Europe
- 3. European Solidarity Corps
- 4. LIFE programme
- 5. Interreg programme
- 6. Creative Europe
- 7. Citizens, Equality, Rights and Values
- 8. Digital Europe
- 9. Connecting Europe Facility
- 10. Internal Security Fund
- 11. Justice Programme
- 12. Single Market Programme (SNP)
- 13. InvestEU
- 14. EU4Health

In addition, three "dedicated" EU programmes to which OCTs are eligible have been included:

- 1. Best 2.0+ and its successor BESTLIFE2030⁴
- 2. Clean Energy for Small islands
- 3. Archipel.eu

1.2.3. Main sources of information

In order to facilitate the continuity and data comparison, this Report has been designed and conducted following the same procedures that were used for the previous two reports on this topic.

The report is primarily based on desk research and analysis of data covering the period from 1 January 2021 until 31 December 2024. The exercise has been conducted during the period January – May 2025.

Thanks to the transparency and availability of information on EU projects provided by the European Commission, the majority of the information was retrieved from the databases of the European Commission, such as:

- Funding & Tenders portal
- Erasmus+ Project Results Platform
- Community Research and Development Information service (CORDIS)
- Creative Europe Project Results Platform
- European Solidarity Corps Projects database

For dedicated programmes, in the cases where information was not publicly available, contacts have been established with the institutions responsible for the programme implementation. In exceptional cases, public information still needs to be completed or cross-checked with the support of the managing authorities.

1.2.4. Main trends observed


According to the 2018 analysis covering the period 2014–2017 (the mid-term of the previous MFF), 106 projects were implemented across the same 13 Dutch, Danish and French OCTs, compared to 344 projects identified in this new study. This represents a 223% increase between the two mid-term evaluations. Seven years later, the level of confirmed funding is ten times higher than during the previous MFF. Notably, half of this funding was awarded through a small number of projects under the Connecting Europe Facility (CEF)—a level of performance that could happen to be exceptional.

Below, the diagrams compare the funding awarded per programme during the 2021–2024 period. Due to the high amounts awarded by the programme CEF, which distort a bit the proportions, two diagrams have been developed, the first one including CEF, and the second, without it.








Greenland (for the most part), along with Aruba, Sint Eustatius, and New Caledonia, have benefited from investments exceeding €26 million through the Connecting Europe Facility (CEF). Beyond these strategic investments, the OCTs collectively secured over €8 million through Erasmus+, making it the second most utilised programme. Erasmus+ also represents two thirds of the total number of projects.

In third place, an organisation from French Polynesia has recently been awarded over €5 million under the LIFE programme - marking the first time an OCT has been successful in accessing this programme. Additionally, the OCTs received nearly €4 million through Horizon Europe, and around €3 million via BEST 2.0+ and BESTLIFE2030.

The European Solidarity Corps also stands out, with close to €1.6 million awarded. An upward trend in participation is visible across several other programmes, with new initiatives emerging in a variety of sectors supported by EU funding.

While the data clearly shows an increase in OCT participation in EU programmes, a deeper analysis of the factors driving this trend would be needed to understand the factors behind this, in order to sustain and reinforce them.

2.1. Erasmus+

Erasmus+ is the EU's programme to support education, training, youth and sport in Europe.

There are 237 projects, totalling 8.804.865 € of EU funding, led by organisations based in the OCTs. All projects indicated in this table have been reviewed individually at the time of the publication of this report. The figures include all projects that have been funded between 2021-2024.

It is important to consider that in the case of the majority of the Erasmus+ actions where the OCTs are involved, the entire budget is allocated to the leading organisation, who then distributes the budget internally according to their consortium arrangements. This budget breakdown is not requested by the National Agencies to the projects to simplify the application and reporting procedures.

Therefore, in the projects where the OCT organisation is a partner, and funding distribution is not available, it is indicated as if the funding going to the partner organisations is 0 EUR. In practice, the projects' funding includes the mobility costs and other expenses from the partners, and the consortium can decide if they divide the funding internally or if the coordinator makes all the payments. This reasoning also applies to projects where the OCT organisation is the "Coordinator", and the entirety of the funding has been allocated to them.

There are numerous Erasmus+ projects where several OCTs are partners, or multiple organisations from the same OCT are involved. Duplicates have been removed to avoid counting the same project multiple times. This is the reason why, in many cases, the number of projects benefitting an OCT / Member State / or the total number, is lower than the sum of the projects at beneficiary level.

2.5. Interreg

Interreg is a series of EU funding programmes that support cooperation. The European Union promotes cooperation between regions and countries to help their economic and social development and tackle the obstacle of borders.

OCTs are not eligible to the Interreg programmes, however as neighbouring countries and territories, certain OCTs can participate in the programmes Interreg Caribbean and the Interreg Northern Periphery and Arctic.

To date, there are no organisations based in the Caribbean OCTs participating Interreg Caribbean programme.

2.5.1. Interreg Northern Periphery and Arctic

The final budget of the Interreg NPA Programme is 51,5 million euro. Between 2021-2027, the Programme will allocate 46.833.778 Euros to projects, of which 39.78.162 EUR in European funding (ERDF) will be available to partners in Member States (Finland, Ireland, Sweden) and 6.855.616 EUR for partners in the non-EU partner countries (Norway, Iceland, Faroe Islands, Greenland). The remaining amount will cover programme administration costs, so called Technical Assistance.⁶

2.13. InvestEU Programme

The InvestEU Programme supports sustainable investment, innovation and job creation in Europe. With the EU budget guarantee provided to International and National promotional banks, the InvestEU programme aims to trigger more than €372 billion in private investments to high EU policy priority areas.

The European Commission works with financial institutions to improve the funding available to SMEs by stimulating the provision of loans and venture capital through financial instruments. There is no OCT local financial institution that has signed an agreement with the European Investment Bank, which is a barrier regarding their access to InvestEU. To date, there are no organisations based in the OCTs participating in InvestEU.

2.14. EU4Health

The EU4Health programme was adopted as a response to the COVID-19 pandemic and to reinforce crisis preparedness in the EU. The pandemic highlighted the fragility of national health systems. The EU4Health programme will bring a contribution to the long-term health challenges by building stronger, more resilient and more accessible health systems.

To date, there are no organisations based in the OCTs participating in the EU4Health programme.





3. Dedicated EU programmes for the OCTs

3.1. BEST 2.0+ and BESTLIFE2030

OCTs entities can benefit from BESTLIFE2030, a grant scheme designed to support biodiversity conservation and the sustainable use of ecosystem services. Specifically tailored for OCTs and Outermost Regions, the programme offers funding opportunities with a focus on ecosystem-based solutions until 2030.

This initiative replaces BEST 2.0+, which awarded approximately €1 million to OCTs in 2020. As this recent call for proposals could not covered in the 2020 edition of the Report on the use of EU programmes by OCTs, it has been included in this updated version. This Report also covers the latest Call for Proposals, which awarded more than €2M to OCTs organisations in 2024.

3.2. Clean energy for EU islands

The Clean energy for EU islands (CE4EUI) secretariat is an initiative of the European Commission, designed to support sustainable energy policies across European islands, including the OCTs.

The Islands secretariat's website acts as a centre to showcase best island practices. It informs about policy and regulatory issues for Europe's island communities and provides dedicated advice for capacity building and clean energy transitioning. Islands can access support via the provision of Technical Assistance, or financial support in the form of individual grants up to 45.000 € for specific projects.

In the OCTs, there is one CE4EUI project, selected in 2021, led by organisations based in Bonaire, Saba and Sint Eustatius, with a duration of three years. This island-group benefits from 60 person-days of technical assistance. The budget breakdown is not disclosed by the programme manager. The value of this assistance is thus not expressed in economic or monetary terms, as the support is delivered through technical expertise rather than direct financial subsidies. Consequently, no financial data can be reported in this report.

3.3. Archipel.eu

Archipel.eu is a pilot project that was co-funded by the European Union between 2021-2023 to provide funding opportunities for artists and cultural organisations from the Outermost Regions and the Overseas Countries and Territories. Throughout the two-year pilot project, 12 projects were selected in the OCTs, amounting to 152.260 € (not including the amounts received by two artists, which are unknown, nor the project that was cancelled).

Archipel.eu launched four calls for proposals, offering grants up to 20 000 € at 90% co-financing rate:

- Fund for the Safeguarding and Promotion of the Intangible Cultural Heritage (Fund ICH) to safeguard
 and promote the intangible cultural heritage, popular arts and practices, and ancestral cultures of the
 ORs and OCTs.
- The Collection Archipel.eu Special Edition aimed to support the dissemination of exhibitions, shows and artistic proposals across the ORs and the OCTs, as well as in continental Europe.
- **Cultural Networking and Cooperation Archipel.eu** supported the creation and development of networks, events, exchanges of good practices and establishment of partnerships.
- Mobility Fund Archipel.eu aimed to improve communication between the ORs, the OCTs and the EU
 to encourage mobility, exchange and cooperation between culture professionals.

5. Conclusions and recommendations

This Report is the third edition of the study, and it marks the first analysis of EU horizontal funding for the 2021–2027 period. The assessment conducted during 2014–2020 served as a key tool to track the evolving involvement of OCTs in EU projects and to evaluate the impact of political efforts aimed at increasing participation.

The present Report builds on that foundation, offering an updated and accurate picture of OCTs success in EU programmes. However, it should be noted that the analysis only includes successfully selected projects, as data on submitted applications is not available. As a result, the full extent of the efforts made by OCTs organisations remains partially unrecorded.

Encouragingly, the outcomes of initiatives led by the European Commission and by OCTA to enhance OCTs participation in EU programmes are becoming increasingly visible. The rise in both the number of funded projects and the diversity of programmes accessed reflects the success of these joint efforts.

Nonetheless, this progress is not evenly distributed between the most populated territories and the least populated territories. Some of the smaller OCTs continue to show very limited or no participation in EU programmes, highlighting the need for targeted support to ensure more balanced access and engagement across all territories.

Trends

The figures on the report allow the extrapolation of certain trends in terms of EU programmes:

- Compared to the mid-term evaluation of the previous MFF (2018 Report), the number of projects has
 tripled, resulting in a tenfold increase in funding allocated to OCTs. Even when excluding the most
 successful programme—Connecting Europe Facility (CEF)—OCTs still received five times more funding
 in the 2021–2024 period than during 2014–2017.
- Connecting Europe Facility appears as the programme that has allocated half of the funding to OCTs in the last years. Greenland, Aruba, Saba & Sint Eustatius have been awarded funding to invest in projects for infrastructure to increase their connectivity. The much smaller project led by New Caledonia under CEF takes place in the Canary Islands, showcasing that the local expertise on the subject is being exported to other territories.
- Erasmus+ continues to be the most popular programme among OCTs, with a total of 237 projects selected in just four years. However, there are certain patterns within the OCTs, with Aruba, Curaçao and Sint Maarten being very successful in youth mobility projects, while French Polynesia and Greenland are very active in terms of school mobilities.
- Projects that combine the efforts of private organisations, NGOs, and OCTs institutions tend to result
 in larger-scale initiatives that contribute directly to public policy goals. A notable example is Aruba's
 participation in a Digital Europe project, which aligns with its E-Government digitalisation roadmap—a
 priority identified in Aruba—EU cooperation.





Main recommendations

The joint efforts of decision-makers responsible for EU–OCT relations, EU programmes managers, and local organisations have all likely contributed, to some extent, to the increased participation of OCTs in EU programmes. This descriptive Report provides a foundation for formulating initial recommendations to help build on this momentum:

- 1. Assess the key factors driving the increased participation of OCTs in EU programmes. A clear understanding of the elements behind the growing success of OCT projects is essential to sustain this positive trend and to establish realistic expectations for the coming years and decades. Based on this in-depth assessment, recommendations can be further refined and expanded.
- 2. **Continue raising awareness of EU programmes among OCTs**, while expanding initiatives that build the capacity of local stakeholders to increase the diversity of applicants.
- 3. **Promote knowledge exchange among OCT-based organisations**. The report highlights areas of strong expertise, with some local actors becoming highly specialised in EU project implementation. Sharing success stories and testimonials can inspire and guide newcomers.
- 4. Where appropriate, the Commission can support recognition of OCTs as EU project partners by sharing information on their status and activities with relevant Directorate-Generals, national authorities, and other institutions.
- 5. OCTs visibility can be enhanced through the publication of a press release highlighting the clear success of decision-makers in supporting OCTs participation in EU programmes, when this report will be made public. Alternatively, this achievement could be featured in the next press release issued on the occasion of the upcoming OCTs–EU Forum.
- 6. **Update this report after the end of the current programming period in 2028**, once all 2027 funding has been allocated, to provide a comprehensive overview of OCT participation in EU programmes.
